Purpose

This report provides an overview of suicides of Aboriginal and Torres Strait Islander peoples in Victoria during 2019 and 2020.

This report supplements the socio-demographic data in the "Suicides of Aboriginal and Torres Strait Islander People" report released by the Coroners Court of Victoria (CCOV) on 30 June 2020. It has been compiled to update organisations in Victoria about the frequency and demography of suicides within Aboriginal and Torres Strait Islander Communities across the state.

Accurately recording and reporting on suicides of Aboriginal and Torres Strait Islander peoples in Victoria is critical to inform program development and other initiatives which aim to reduce suicide rates across Victorian Aboriginal Communities.

The Victorian Suicide Register (VSR) was the data source for the material presented here. Please see the 30 June 2020 report for an overview of the VSR, its case inclusion criteria, the method for compiling the data, and caveats when interpreting the data. The Coroners Prevention Unit, a business unit within the CCOV, extracted the relevant data for this report from the VSR on 11 January 2021.

Data update

The following data pertains to Aboriginal and Torres Strait Islander people who passed by suicide, and whose passing was reported to CCOV between 1 January 2019 and 31 December 2020.

1. Annual frequency

Table 1 shows the annual suicide frequency among Aboriginal people and all people in Victoria during the period 2019-2020. There were 21 suicides of Aboriginal people reported during each year.
