Coroners Prevention Unit

The Coroners Prevention Unit (CPU) is a specialist service for coroners created to strengthen their prevention role and provide them with expert assistance by:

- reviewing a range of reportable and reviewable deaths
- collecting and analysing data relating to reportable and reviewable deaths
- assisting coroners in the development of prevention-focussed coronial recommendations
- receiving and publishing coronial recommendations.

The central goals of the CPU are to:

- improve the quality and applicability of coronial recommendations
- increase the uptake and implementation of coronial recommendations
- contribute to the reduction of preventable deaths in Victoria.

Coroners Prevention Unit and the coronial process

The Coroners Prevention Unit may contribute at any stage of the coronial process, including:

When a death is initially reported – through the provision of advice that can be used by coroners to:

- decide on the direction of the investigation
- ensure that essential evidence is gathered
- identify any prevention opportunities relevant to an individual or group of similar cases.

When recommendations are being developed – through the provision of expert advice to coroners on:

- the nature and extent of risk factors
- evidence on effective countermeasures
- identification of relevant stakeholders who may be affected by the recommendations
- information on relevant legislation, standards, codes of practice and guidelines
- information on similar previous and subsequent cases and recommendations.

When recommendations are being finalised – by engaging with relevant stakeholders at the direction of coroners to ensure that any proposed coronial recommendations are reasonable, viable and likely to be effective.

After recommendations have been made – by receiving and collecting information on the responses to and implementation of coronial recommendations.

Additionally, the CPU undertakes both individual and collaborative research projects to support coronial investigations to generate a better understanding of preventable deaths in Victoria and identify intervention opportunities.
