
1. Any report concerning the inquest into the death of Samir Ograzden that identifies, or tends to identify:
 - a. the name of any caller to the emergency telecommunication service operated by the Emergency Services Telecommunications Authority (ESTA) seeking police assistance in the lead up to Mr Ograzden's death;
 - b. the name of any ESTA police call takers or dispatchers involved in any of the audio recording provided by ESTA to the inquest.


