# Ambulance Victoria Submissions dated 17th June, 2010

### Paragraphs 38-42

# Changes to Procedures following 31 December 2008

- 38. Ambulance Victoria have introduced a number of changes since December 2008. Some of those changes relate directly to the death of Mrs Campbell, whilst others were changed already in train and consequent upon the merger of the Metropolitan Ambulance Service and Rural Ambulance Victoria. The statement of Mr Mark Rogers General Manager Specialist Services AV outlines the history [E27]. The largest system changes were already planned. However, the changes have been accelerated and have been or are being implemented. These changes should eliminate the sequence of the events surrounding the death of Mrs Campbell.
- 39. The initial response by Ambulance Victoria to prevent a recurrence was expeditious and effective. The first step was to modify the call taking procedure so that no matter how the cal originated, all inter-hospital transfers would be processed by the call taker according to the AMPDS, using the ProQA system. In addition, even before proceeding to ProQA, the call takers are required to enquire of the hospital or doctor whether the transfer is time critical and if an ambulance is required in less than 1 hour [T176]. If it cannot wait 1 hour then the procedure is for the doctor or nurse to be taken through the questions and answers which require greater details [T204-438-9]. The call takers are also required to take a full set of observations of the patient, including blood pressure, pulse rate, temperature etc, from the hospital. When the caller is taken through the ProQA system, card 33 is used. The card prompts the call taker to ask certain questions and, depending upon the answer, to ask other questions. The use of the card 33 will result in the case being entered into the Computer Aided Dispatch system as a priority one [E25]. The change in that system was implemented on 19 January 2009, less than 3 weeks after the death of Mrs Campbell [T439].
- 40. Further steps were also taken to ensure that the Cobram District Hospital and other hospitals in the region, were aware of the services of Adult Retrieval Victoria and of the system for making calls to Ambulance Victoria for inter-hospital transfers. Adult Retrieval visited CDH in February 2009 to further explain its role [T440]. The meeting at the Cobram Hospital took place on 25 February 2009. A poster setting out the telephone numbers and procedure for calling an ambulance and ARV was produced for display at points where telephone calls were made in the hospitals [E26;T439]. Mr Bush gave evidence that the Cobram Hospital had created its own document in similar terms, and where they were located at the hospital [T167].
- 41. The evidence of Mr Cook, the Regional General Manager for the Hume Region of Ambulance Victoria, outlined the changes that have been made [T437 et seq;E25]. The merger of the Metropolitan Ambulance Services and Rural Ambulance Victoria meant that it was planned that similar procedures and operating guidelines would be used throughout the new Ambulance Victoria. It would also mean that the Rural Ambulance facilities would be upgraded, closer to what was available in Melbourne.

Although Melbourne ambulances had Automatic Vehicle Location equipment available for a number of years, it was not until a new radio network was put in place that rural ambulances were able to have the same capability and dispatchers able to visually ascertain the location of an ambulance at any particular time [T453]. That system came into effect in July 2009. Further, the dispatchers have been relieved of a number of duties they had previously been required to perform at the same time as dispatching ambulances [T298, 310-5,207,440]. This gave them more time to concentrate and apply themselves to the exigencies of the cases. More significant changes have been in the form of engaging clinicians to oversee the allocation of ambulances and the management of transfers between hospitals. As from Monday 19 April 2010 all inter-hospital transfers have been visible to a centralised position created at the Ballarat Operations Centre [T440]. This position will be transferred to the Centre where the Emergency Services Telecommunication Authority will manage the call taking process by 25 June 2010. ESTA will commence providing service on 30 June 2010 with the first transition of the Wangaratta Operations Centre. Nonparamedic call takers take the calls following the AMPDS procedures by entering the cases into the computerised system and ambulances are automatically dispatched with automatic coding and with appropriate crews. The system is overseen by the clinician and by resource officers, and backup ambulance personnel and other ambulance resources [T442]. Queries from hospitals about transfers of patients and their clinical state are dealt with by the clinician, whose job is to do that and he is not required to manage other duties, such as dispatching or other organisational matters [T446]. It is purely a clinical task. If a hospital rang back about an ambulance for an ill patient, then the call would be directed to the clinician and the matter would be able to be considered in full [T312]. This means that from the 30<sup>th</sup> June 2010 the Wangaratta Operations Centre will be closed and all Ambulance calls in the Hume region will be directed to the Ballarat Operations Centre, working through the ESTA call takers and dispatchers and with the clinical support of Ambulance Victoria personnel. This is a system similar to that which operates in the Melbourne metropolitan area. This procedure would eliminate any delay in that an ectopic pregnancy would be handled via the AMPDC System using the ProQA and Protocol 33. This is an amendment to AV protocols [T443]. There is an audit function in the AMPDS to check compliance with the protocols [T444].

42. To better facilitate the co-ordination between healthcare providers, Ambulance Victoria senior staff have regular meetings with the large regional hospitals and regular meetings with smaller hospitals. The regular meetings occur on a quarterly basis and there is, in addition, informal communication as deposed to by Mr Cook [T447-450,453]. There are also regular meetings with the Department of Health and with the Regional Critical Care Advisory Committee. The Health Care Professional's Guide to Ambulance Services, which outlines the services provided for health care professionals in hospitals and how to access ambulance and retrieval services throughout Victoria is to be redeveloped. Operation Centre staff have undergone revision of the time critical guidelines and associated Clinical Practice Guidelines at continuing professional education programs and that is an ongoing process [T449]. Again, it would probably be helpful if the rural and regional hospitals made it clear to the Ambulance Victoria exactly what their capabilities and facilities were in terms of providing care in circumstances where an urgent or emergency ambulance may be required.





ASSISTANT DISPATCHER - PAT:

Okay, well I'm - - -

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Like, we've got quite a sick lady here.

ASSISTANT DISPATCHER - PAT:

Yeah, no, well, I wasn't aware that she was that sick, okay.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

So who has - who's - who's not passed it on, like this needs some quite - - -

ASSISTANT DISPATCHER - PAT:

Yeah, who's not passed it on?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

Well, I - I'll find out for you, but - I'm not - - -

(UNKNOWN FEMALE IN BACKGROUND):

Excuse me.

ASSISTANT DISPATCHER - PAT:

Yeah.

(UNKNOWN FEMALE IN BACKGROUND):

..... there, ..... .....

ASSISTANT DISPATCHER - PAT:

Okay. (TO COBRAM HOSPITAL) We'll have a look at -

I'll have a look at the case now, okay.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yep.

ASSISTANT DISPATCHER - PAT:

Yep. It's alright.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Is It?

ASSISTANT DISPATCHER - PAT:

No, I - - -

TOBRAM DISTRICT HOSPITAL - GENEVIEVE:

Not when you're here with the patient it's not alright.

ASSISTANT DISPATCHER - PAT:

No - no, well, I - well, I - actually I've been in the ambulance for 30 years and I've dealt with a lot of sick patients myself, okay.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah, okay, alright.

ASSISTANT DISPATCHER - PAT:

And I know it's not easy, yeah.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

I just think, you know, they're just leaving now - -

ASSISTANT DISPATCHER - PAT:

Yeah.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Which is - yeah.

ASSISTANT DISPATCHER - PAT:

No.

(MARTY IN BACKGROUND):

.....

ASSISTANT DISPATCHER - PAT:

Yeah, hang on - we're - we're talking to my colleague, go on Marty. Yep.

(MARTY IN BACKGROUND):

Okay. The crew has took longer than ....

.... thought.

ASSISTANT DISPATCHER - PAT:

Yep.

(MARTY IN BACKGROUND):

.....

ASSISTANT DISPATCHER - PAT:

Yep. We did despatch the car some time ago.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

Okay. I've just spoke to my colleague.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yes.

ASSISTANT DISPATCHER - PAT:

Because we did realise that the patient had a ectopic.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yep.

ASSISTANT DISPATCHER - PAT:

And had had pain.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yep.

ASSISTANT DISPATCHER - PAT:

And we - we - we put the job on the Shepparton card, to come up and pick the patient up.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

And unfortunately they do these - we've got electronic re-, records we do at the hospital and then they took longer than what we thought to do their electronic record of the - of the data at the Goulburn Valley Hospital.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Mm'm.

ASSISTANT DISPATCHER - PAT:

So as soon as - they've just cleared now and told us that they've taken a bit longer than what they thought and they're heading up now. So we're only go-, we didn't know how long they were going to take, you know.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah. Yeah.

ASSISTANT DISPATCHER - PAT:

Yeah.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

I mean it's pretty isolating up here.

ASSISTANT DISPATCHER - PAT:

I understand, yeah, look, I'm - I don't know that area very well.

Haven't been up here that long.

Yeah, sure, yeah. And she's had 5 of morph has she

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

She's had - - -

ASSISTANT DISPATCHER - PAT:

And 10 ml of Max.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Five morph, no we can't give her any more morph because her blood pressure is - - -

ASSISTANT DISPATCHER - PAT:

Yeah. Yeah.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

ASSISTANT DISPATCHER - PAT:

What's - what's her BP's now 70 odd is it?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Has been most of the time.

ASSISTANT DISPATCHER - PAT:

Yeah.

See, look I'm - haven't been able to - I'm not trying

to .... I haven't been up here that long, I'm not, you know, getting use to the area, you know.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yep.

ASSISTANT DISPATCHER - PAT:

And sometimes we - you try and sometimes keep the area covered with your Cobram car, then bring the other car up, do you know what I mean.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah, .... crew coming straight from here to Shepparton, you know, an hour and a half ago.

ASSISTANT DISPATCHER - PAT:

Did, yeah, okay.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

Yeah.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

Well, I'll discuss that with my colleague. I - it depends on how the case comes through and how it's coded at times, you know, and so - no, I'm sorry

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Well, first up was a 72 on 43 blood pressure.

ASSISTANT DISPATCHER - PAT:

Yeah.

OBRAM DISTRICT HOSPITAL - GENEVIEVE:

That's you know, sort of - - -

ASSISTANT DISPATCHER - PAT:

Well, I mean - - -

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

..... Yeah.

ASSISTANT DISPATCHER - PAT:

It's what sorry?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

I've got - I'll follow it through as well.

ASSISTANT DISPATCHER - PAT:

You worked in the ambulance service?

In the ambulance?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yes.

Where at?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Air ambulance.

ASSISTANT DISPATCHER - PAT:

What's your name, I probably know you? I do, it's Pat Kelly here.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Pat, how are you, it's Genevieve.

ASSISTANT DISPATCHER - PAT:

I know you, Genevieve.

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

Yeah.

ASSISTANT DISPATCHER - PAT:

Yeah, you remember me?

COBRAM DISTRICT HOSPITAL - GENEVIEVE:

I do, yes.
