ORDER THAT:

- 1. Pursuant to s.58 of the Coroners Act 1985 there be no report made of the inquest touching upon the death of Anthony Clarke or any part of the proceedings of the said inquest or of the publication of any evidence given at the said inquest relating to or in respect of the course content and training given to operational police members pursuant to Project Beacon and the Victoria Police Operational Safety Tactics and Training Courses ("OSTT") as disclosed in the documents referred to in Attachment A hereto or in any oral evidence given by Victoria Police members in relation to such course content, training, defensive tactics, procedures and methodologies.
- 2. Order 1 shall operate only in respect of the specific details of any training or instruction, including the precise terms of the training modules, manuals and other documents referred to in Attachment A, but shall not extend to evidence regarding the topics of training or instruction provided.
- 3. The order to remain in force until further order.
- 4. Liberty to the parties and to members of media to apply.
