#### Re: Kalon Tippett - Response to the Coroner's recommendation

I refer to your correspondence dated 6 September 2010 and respond accordingly.

#### Recommendation

"Pursuant to Section 72(2) of the **Coroners Act 2008**, I make the following recommendation connected with the death:

1. "Agencies such as Workcover and farmers' organisations should continue with safety campaigns to increase farmer awareness of safety, and need to implement strategies to avoid tragic and preventable deaths."

The unfortunate death of Kalon Tippett was a tragic loss to the farming community. Safety should be a number one priority at any workplace, with agriculture being no different with respect to safety.

#### The VFF believes that: the Coroner's recommendation has or will be implemented.

The VFF is involved in a number of safety initiatives.

#### VFF is a party to the FarmSafe Alliance.

The FarmSafe Alliance is made up of the representatives of the Victorian Workcover Authority, Australian Workers Union, Department of Primary Industries and the Department of Health and the Victorian Farmers Federation.

The FarmSafe Alliance's objective is to work co-operatively to achieve a reduction in injury and death resulting from farm activities. In order to achieve this, a number of initiatives are developed through the Alliance including delivering safety messages to the farming community. With the funding from the Victorian WorkCover Authority, Department of Primary Industries and the Department of Health, Farm Safety Managers are engaged to communicate with and inform key stakeholders in rural communities about health and safety on farms, develop and support the implementation of solutions which improve health and safety on farms, develop the partnerships the FarmSafe Alliance has, and build on the complementary strengths and capabilities and link local communities and groups to increase awareness of occupational health and safety issues on farms.

The FarmSafe Alliance has been in operation for a number of years providing valuable safety messages to the farming community.

#### Victorian Farmers Federation Farm Safe Victoria Committee

The VFF has a committee devoted to farm safety. The VFF FarmSafe Victoria Committee comprises various representatives from the VFF itself, Country Women's Association, the Country Fire Authority, the Country Australian Doctors Association, Department of Health and Primary Industry and Monash University and the Alliance Managers and officers. The committee meets four times a year to discuss safety and health in relation to the farming community. The chairman of Farm Safety Victoria is a VFF member.

The VFF members and staff have a commitment to safety. When there is an opportunity for safety training to be included as a compulsory unit in a teaching syllabus the VFF support or submit for it to be included. This is to ensure that safety is given a high focus at the workplace.

The Chairman of the Committee after seeing small children on a quad bike in The Weekly Times on 22 September 2010, wrote to the paper explaining that that there are no excuses for ignoring safety and noting that for many years the Victorian FarmSafe Alliance has been trying to change farmer attitudes towards safety on the farm. When the opportunity presents itself the committee will speak out about the need to change the negative attitudes towards safety on the farm. A copy of both the original photograph and the Chairman's response is enclosed.

The VFF has and will continue to write safety messages in the VFF Vic Farmer Magazine to increase farmer awareness of safety.
